- 2. The reporting officers are advised to relieve the concerned officer/s to enable them to report at new place of posting on or before reporting date.
- 3. The officers may complete handing over and taking over formalities before joining at their new place of posting.
- 4. The officers, who have been transferred on request and will not be entitled for any TA/DA benefits other than the following:
 - a) Second class railway fare for self and dependents.
 - b) Actual transportation charges of household goods as per TA/DA rules. (Packing, loading, unloading, insurance and other charges and one-month basic salary i.e. lumpsum grant are not payable); and
 - c) They are also not entitled for any joining period leave.
