## 1. Indicative Scope of work:

- Review of Density v/s Capacity trade-offs between space and power
- Review of planned space for Rack Layout and Rack Positioning
- Review of Raised floor systems
- Review of Lift, Shipping, Storage Arrangements
- Review of Emergency Exit mechanism
- Review of compliances to Local Authorities e.g. BMC Local authorities amenable to building use.
- Review /Assess proximity to sources of vibration and high-risk sources (such as airports and rail lines)
- Review of Telecom System Entrance and Cabling Arrangements
- Review of Rubbish/Scrap/Waste removal Site
- Review of acoustic and aesthetic screening for mechanical equipment
- Review of Power Backup site i.e. UPS, Diesel Storage Consider local code compliance regarding fuel storage and noise abatement
- Review of Structural Materials used e.g. Steel, Reinforced Concrete
- Review of Peripheral Distance to Local Disaster Control Bodies e.g. Nearest Fire Station, Hospital, Police Station
- Visual Inspection of structure as per floor plan

- Inspection of material used for building the DC floor, Floor height and placement of AC vents, Height of building/floor from ground level
- Load bearing capacity, Slab Strength, load distribution etc.
- Plan of leakage system
- Structures of water pipes in the building
- Review of Fire department permissions for use of gases like FM 200 or NOVEC 1230
- Review of Fire Suppression Paint Materials
- Use of Fireproof materials for DC building
